

# Carnet de Passages - Table of fees



ADAC Touring GmbH

For motorbikes, passenger cars, caravans, busses, watercraft, small aircraft, lorries and trailers.

## Issuing fees

	Members	Non-members
Carnet de Passages	€150	€250

For vehicles with an export licence plate an additional **special fee** of **€155** has to be paid.

## Guarantees

For each Carnet de Passages a deposit must be lodged. It may be posted either as cash deposit (**security**) at ADAC or as a **bank guarantee**.

## Dispatch costs

Carnets which are not collected personally are sent either by registered mail or by DHL courier service.

- Postage costs for registered mail are **€ 4.10** within EU countries  
**€10.20** to other countries.
- If delivery by DHL courier service is required, please enquire about the costs at the ADAC headquarters in Munich. Such costs will be charged separately.

## Payment

Carnets are issued exclusively at the **ADAC headquarters (ADAC Zentrale) in Munich**. Prior to dispatch, the amount of security as well as the document fee and delivery costs should be remitted to:

A copy of the money transfer form **confirmed** by the bank (no receipt stamp!) must be submitted along with the application documents.

If the Carnet de Passages is collected at the **headquarters in Munich**, both the security and the document fee can also be paid in cash on the spot.

## Important note:

In case the **security** is lodged by a person other than the carnet holder, an "authorised recipient of money", including complete address, must be appointed prior to the issuing of the Carnet de Passages.

For lodging of a **bank guarantee** the ADAC form „Bank-Bürgschaftserklärung“ available at the ADAC headquarters in Munich must be used which must be **confirmed by a German bank**. The original must be submitted along with the application documents.

If the bank guarantee is issued by a bank which does not have a local presence in Germany it must be additionally acknowledged by the German correspondent bank of the issuing bank.

## Guarantees

### 1. Amount of guarantee for vehicles not covered by item 2 or 3:

current market value of vehicle of up to	€15,000 = €1,500
current market value of vehicle of up to	€25,000 = €2,500
current market value of vehicle of up to	€50,000 = €5,000
current market value of vehicle of up to	€75,000 = €7,500
current market value of vehicle of more than	€75,000 = available at ADAC on request.

### 2. Special guarantees - not for motorbikes:

Carnet de Passages valid for:

#### a) South African Customs Union (South Africa, Namibia, Botswana, Swaziland and Lesotho)

current market value of vehicle of up to	€15,000 = € 5,000
current market value of vehicle of up to	€25,000 = € 7,500
current market value of vehicle of up to	€50,000 = €15,000
current market value of vehicle of up to	€75,000 = €20,000
current market value of vehicle of more than	€75,000 = available at ADAC on request.

#### b) Egypt, India, Iran, Pakistan

current market value of vehicle of up to	€7,500 = € 5,000
current market value of vehicle of up to	€15,000 = €10,000
current market value of vehicle of up to	€25,000 = €15,000
current market value of vehicle of up to	€50,000 = €30,000
current market value of vehicle of up to	€75,000 = €40,000
current market value of vehicle of more than	€75,000 = available at ADAC on request.

### 3. Special guarantees for motorbikes:

Carnet de Passages valid for:

#### Egypt, India, Iran, Pakistan and South African Customs Union (South Africa, Namibia, Botswana, Swaziland and Lesotho)

at current market value of vehicle of up to	€15,000 = € 3,000
at current market value of vehicle of up to	€25,000 = € 5,000
at current market value of vehicle of up to	€50,000 = €10,000
at current market value of vehicle of up to	€75,000 = €15,000
at current market value of vehicle of more than	€75,000 = available at ADAC on request.
