DECLARATION AND AGREEMENT

I hereby make application to RAC Motoring Services for Customs documents in respect of the vehicle described overleaf.
WARNING - Any Customs documents issued as a result of this application must not be used for the importation of the vehicle into any country in which the applicant is at present or intends to be principally resident (see paragraphs (d), (e) and (f) of the subjoined declaration).

I DECLARE THAT:

- a) The customs documents are required for my personal use;
- b) The vehicle described overleaf is my property, or I am authorised by the owner to make full use of it;
- c) The vehicle is not the property of any person or firm resident or established in any of the countries into which I shall be temporarily importing it whether or not under cover of any Customs documents for which I now apply or in any other country for which such Customs documents are valid;
- d) I shall not have resided in any of the said countries for an aggregate period exceeding twelve months during the twenty-four months immediately preceding the date of importation of the vehicle into the country in question;
- e) I shall not have kept the vehicle or any other temporarily imported vehicle in any of the said countries for an aggregate period exceeding twelve months during the twenty-four months immediately preceding the date of importation of the vehicle into the country in question;
- f) My stay in any of the said countries will only be temporary and of less than six months' duration. (Note: up to twelve months is allowed in certain countries. RAC can advise);
- g) The particulars given by me below and overleaf are true and complete.

I AGREE:

- i) Not to leave, use for hire, lend or sell the vehicle in any of the countries to be visited or otherwise contravene the conditions of the temporary importation facilities applicable;
- ii) To place the vehicle or the salvage therefrom in safe custody if it is seriously damaged or destroyed by fire or other cause while in any of the said countries and to report the event immediately to RAC Motoring Services at the address overleaf, and to its local agent;
- iii) To export the vehicle from the said countries within the period of validity of the Customs documents;
- iv) That the Customs documents remain the property of RAC Motoring Services and that I will return them on completion of my tour;
- v) To use the Customs documents strictly in accordance with the instructions issued to me and the directions of the Customs authorities concerned;
- vi) To indemnify RAC Motoring Services in respect of any payment they may have to make to satisfy the claim(s) of any Customs authorities in respect of the vehicle arising out of the issue of the Customs documents to me or my use thereof;
- vii) That no interest will accrue to my account on part, or total cash indemnity deposit paid to RAC Motoring Services.
